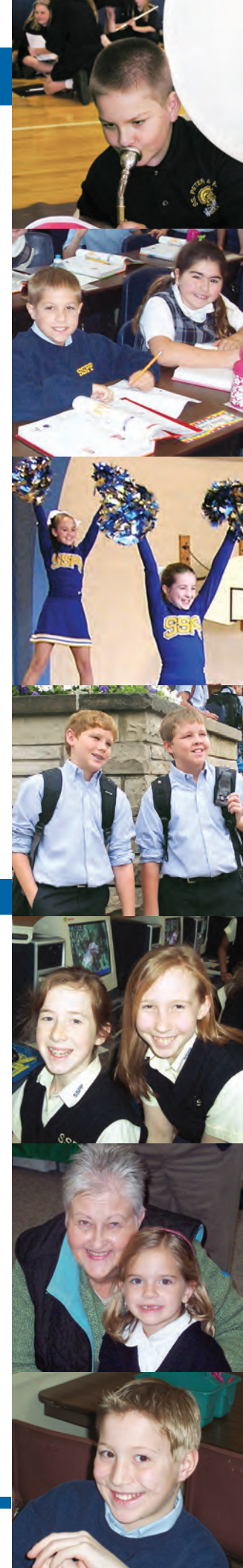

A Legacy of Faith

Have you remembered
Ss. Peter and Paul School in your will?

Like every private non-profit institution, Ss. Peter & Paul School relies on a variety of revenue sources to fund both its short-term and long-term goals. Given the limitations of tuition, parish subsidies and fundraising, it is important that our school have another means of growing endowments and meeting operational expenses. Over twenty years ago our school leaders had the foresight to promote planned giving with our donors. This was seen as an attractive option for people who believed strongly in the educational value of a Catholic school but who currently were not in a position to support the school as generously as they would like.

Those who have made a planned gift to our school become members of our **21st Century Heritage Endowment Society**. To date, over 60 families have made such a decision and their names are listed on a plaque by the entrance of the Jr. High. The most common planned gift is a general bequest from which the donor leaves a specified amount of money to our school. The second most selected method is the transference of a paid-up insurance policy that lists Ss. Peter & Paul School as beneficiary.

How do you include our school in your will or living trust? The most common way people remember Ss. Peter & Paul School in a will or living trust is through a charitable bequest. You do not have to rewrite your current documents. You simply add an amendment, called a codicil, to your will or living trust. The Development Office can provide you with some suggested language you can have your attorney review. If you have questions about bequests, call the Development Office at (630) 355-0113.
